EXERCISE INSTRUCTION FOR EXERCISE NOBLE SKYWAVE 2023

Ref: EX NOBLE SKYWAVE 2023 – CALL FOR PARTICIPATION

1. SITUATION

- a. <u>General</u>. The Communications and Electronics (C&E) Branch is holding its annual Professional Development week at Canadian Forces Base (CFB) Kingston, from the 23rd to the 29th of October 2023. 21 Electronic Warfare Regiment (21 EW Regt), on behalf of the C&E Branch, will use this opportunity to conduct Ex NOBLE SKYWAVE 2023 (Ex NS 23). The exercise will see the establishment of voice and data links between domestic and international teams via High Frequency (HF) Skywave propagation.
- b. <u>Participation</u>. Invited to participate are all Regular, Reserve, or Auxiliary Force units with HF radio communications from Canada, Peru, the United Kingdom, the United States of America, Australia, New Zealand, and any other interested international partners and allies. Members of the Canadian Forces Affiliate Radio System (CFARS) and the US Military Auxiliary Radio System (MARS) are also invited to participate.
- 2. <u>MISSION</u>. 21 EW Regt will organize and facilitate Ex NS 23 from 24 2200Z OCT 23 to 26 1600Z OCT 23 in order to provide a venue to confirm HF interoperability and prowess amongst the international community.

3. EXECUTION

a. <u>Concept of Ops</u>

(1) <u>Intent</u>. I intend to build on the success of previous iterations of the Ex NS series by involving the C&E Branch, The Canadian Forces School of Communications and Electronics (CFSCE), and the international community in creating a valuable training exercise that challenges HF Skywave skills across both domestic and international teams. The spirit of the competition will be friendly and emphasize comradery between participants. In accordance with the code of conduct, rude or inappropriate behaviour will not be tolerated.

- (2) Scheme of Manoeuvre. Within a competition construct, participating teams will earn points for successful contacts with other participants. The scoring matrix for this competition will reward teams that are able to achieve contact with more distant participants. Teams are responsible for their own respective broadcast detachments, stations, sites, and personnel. The Officer in Charge (OIC) will retain responsibility for the overall conduct of the competition, including scoring. Throughout the exercise, individual units are responsible for the setup, tear-down, and manning of their detachments, and will bear any associated costs or fees. The exercise and competition will occur in 3 phases:
 - (a) Phase 1 - Preparation. (Now -24 Oct 23). The preparation phase will see the Ex planning team generate the appropriate staff, support, instructions and invitations to participants. The competition instructions will be detailed further in the Communications and Electronics Operating Instructions (CEOIs) via publication on the Ex NS 23 web application (Web App) at https://nobleskywave.ca/. Teams will confirm their participation through the registration portal within the Web App. Teams wishing to conduct a comms check prior to the Competition start 24 2200Z OCT 23 may do so at their discretion. Note that the Net Control Station (NCS) will not be monitoring on any HF radio net prior to the competition start. Therefore, comms checks should be organized between teams, the competition SLACK Channel may be used to facilitate planning between teams. This phase ends upon the establishment of the NCS at CFB KINGSTON no later than (NLT) 24 2000Z OCT 23;
 - (b) Phase 2 Competition. (24 26 Oct 23). While operating on a 24hr basis (in order to accommodate all time zones), teams will earn points for successful radio checks between stations. The competition will consist of 5 Stages including the announcement of the winners for each category following End Ex:
 - i. Stage 1: Establishing the Net;
 - ii. Stage 2: Free Play Challenge;
 - iii. Stage 3: Team Contact Challenge;
 - iv. Stage 4: Back to the Future Challenge; and
 - v. Stage 5: End Ex.
 - (c) <u>Phase 3 Post-Ex Drills.</u> (26 Oct 23 and onward). Once the Ex has been completed, the Planning team will close all HF nets related to Ex NS 23 and consolidate contact information to facilitate call-outs for next year's competition. Prizes and letters of appreciation will be distributed. Individual teams will be responsible to tear down their stations and return to normal

activities. AAR points from participating teams regarding the Ex will be due to the OIC, Lt Shurepa, NLT 03 Nov 23.

- (3) <u>Main Effort</u>. Ensure clear and timely communication between participants and the NCS/Ex OIC via the Ex NS 23 Web App, email, and the SLACK channels.
- (4) End State. My end state will be achieved when the Ex has concluded, results are published, prizes and letters have been distributed, the Ex NS trophy has been updated, and contact info and pertinent comments have been collected for future iterations of the competition.

b. <u>Groupings and Tasks</u>

- (1) <u>Planning Team (OIC)</u>
 - (a) Submit frequency requests;
 - (b) Bring online and maintain the exercise Web App;
 - (c) Maintain Web App for use as a primary resource for document and information distribution;
 - (d) Provide participants exercise instructions and CEOIs;
 - (e) Accept registrations and issue supporting documentation and information to teams;
 - (f) Ensure continuity of planning teams, by creating timeline framework for future planning teams as well as Web App maintenance instructions;
 - (g) Establish Exercise Control Command Post (EXCON CP) as the NCS:
 - (h) Designate Call-signs and disseminate to teams;
 - (i) Establish Web App monitoring within the NCS to enable global coordination with all participating detachments and stations;
 - (j) Administrate and monitor competition to ensure fairness to all teams involved;
 - (k) Collect lessons learned / pertinent comments from all competitors and prepare after action report to present to C&E Branch Adjutant; and
 - (1) Prepare and disseminate thank you letters.
- (2) <u>Participating Teams</u>
 - (a) Indicate intent to participate to the OIC as soon as possible;

- (b) Complete formal registration on the https://nobleskywave.ca/
 Web App by the deadline; ensuring to provide accurate information and to monitor the given email address for updates;
- (c) Register for and join the SLACK Channel under the Chat tab on the Ex NS 23 Web App;
- (d) Submit frequency requests / ensure authority to transmit through respective communications staff or national spectrum management organization as applicable;
- (e) Prepare HF equipment and personnel as required in preparation for the competition;
- (f) Participate within the guidelines outlined within this instruction and the CEOIs. Abide by the code of conduct outlined in this document; and
- (g) Provide the OIC with any lessons learned or comments regarding the conduct of the exercise upon completion of Ex NS 23.

 - (a) 27 0000Z SEP 23– Registration opens;
 - (b) 07 Sep 23 Formal call for participation letters released;
 - (c) 15 Sep 23 Exercise Instructions released;
 - (d) 15 Sept 23 CEOIs released;
 - (e) 18 0000Z OCT 23 Deadline for registration;
 - (f) 23 0000Z OCT 23 Final participant, call-sign, and location lists published;
 - (g) 24 2100Z OCT 23 NCS will start monitoring Ex NS 23 HF frequencies;
 - (h) 24 2200Z OCT 23 Competition begins, Stage 1 begins;
 - (i) 26 1600Z OCT 23 Competition ends, Stage 5 ends, winners announced; and

- (3) Registration. Registration for the exercise can be completed on the exercise Web App at https://nobleskywave.ca/. Recognizing the importance of timely information and the efforts required of the formal application process, an informal email to the OIC signaling the intent to participate will ensure your team receives all pertinent documentation;
- (4) <u>Scoring</u>. The scoring criteria will be released with the CEOIs. Teams which may be unable to participate various stages of the event due to eqpt or manning are still welcome to participate in all other stages;
- (5) <u>Code of Conduct</u>. All participants and staff will be courteous and respectful at all times on all forms of communication including the SLACK channels and over the radio. Attempts to cheat (log falsified contacts), and abusive or offensive language, will be punished by reduction in score and/or removal from the Exercise at the discretion of the Ex OIC; and
- (6) <u>Disclaimer</u>. As a voluntary exercise, all costs are borne by the participating units and this exercise should not take precedence over an official or operational task.

4. SERVICE SUPPORT

- a. <u>Concept of Support</u>. Participation in the event is voluntary. Outside of providing the exercise framework and the competition concept, neither 21 EW Regt, the C&E Branch, nor CFSCE have allocated resources to support other units. Support is ultimately borne by the units for their participating teams, detachments, or stations; and
- b. <u>Financial</u>. 21 EW Regt and CFSCE will rely on the C&E Branch to support the EXCON. Any financial commitments for the NCS will be confirmed with the Branch Adjt prior to commitment.
